Arabic dailies case adjourned

Senior officials acquitted of beating his maid to death

KUWAIT CITY, April 24: The Criminal Court has acquitted an assistant undersecretary of beating his Asian housemaid to death.

The defense counsel, Attorney Khaled Al-Enezi, argued against the allegation; saying his client did not beat the maid. He said the testimony of another maid against their sponsor was false, asserting the second maid had a fight with the victim up to the extent of using sharp object to attack the When his client returned from work, his



wife informed him that the maid in charge of food refused to prepare lunch due to the fight, so he just opted to have a nap in the room. He suddenly heard noise from the ground floor of the building, so he knew the maids had resumed the fight again.

According to the lawyer, his client's tight schedule, owing to his position, did not give him the opportunity to intervene in the problems among maids. He then demanded for the acquittal of his client due to the absence of incriminating evidence.

Case adjourned: The Complaints Section of Administration Court presided over by Judge Ahmad Al-Habeeb adjourned to April 29 the two petitions filed by Al-Watan and Alam Alyawm newspapers against the judicial decision that was issued to suspend their publication activities for two weeks.

The government's lawyer Ali Munawer requested the court to reject the petitions, as the decision taken by the Fast Track Court was temporary and was issued while investigations were ongoing due to the necessity of the situation, as a final verdict is not required to be

issued in such cases based on Article 15 of the Publication and Press Law 3/2006.

Lawyer Munawer indicated that the violations committed by the two newspapers were cited before the secret parliamentary session, affirming that all newspapers were treated in the same manner in the implementation of the law.

On the other hand, counsel to Al-Watan Lawyer Rashed Al-Rada'an and counsel to Alam Alyawm Lawyer Sultan Al-Qahtani requested the court to accept the petitions and annul the decision taken by the Fast Track Court. They based the petitions on Article 164 of the Procedural Law, stressing that the decision lacked the necessity factor.

Ruling revoked: The Misdemeanor Section in the Court of Appeals, chaired by Judge Mohammed Al-Khalaf, revoked the ruling of the First Instance Court that had previously sentenced a customs broker to one month in jail with hard labor to be followed by deportation for stealing mobile phones from a local telecommunication company.

Attorney En'am Haider, who represented the accused in court, provided documents related to the mobile phones dispatched from the company and a certificate from the Customs General Department. She then asked the court to acquit her client and treat him with utmost compassion.

The higher court overturned the verdict of the lower court and acquitted the accused after a thorough analysis of all the pieces of evidence and arguments presented by both sides.

Hearing put off: The Court of Appeal adjourned to April 30 the appeal filed by the Public Prosecution and several lawyers, Jaleel Al-Tabakh, Hassan Al-Matrouk, Mohammad Bu Hamad and Ismail Al-Sahaf against the verdict issued by the Court of First Instance, which acquitted Abdullah Al-Nafeesi of allegedly causing division in the society and offending the Shiite sect.



KUWAIT CITY, April 24: Ahmadi patrol officers have arrested two Asians for trafficking in alcohol.
